Terms for Startup-membership

A Startup Membership at Danish Chamber of Commerce gives your business a strong and reliable partner.

To be eligible for one-year free Startup Membership the business must:

- Have existed for less than five years
- Have a unique CVR-number and not belong to a mother company
- The founders must be a part of the daily operations
- Not be covered by or have entered a collective agreement

The Startup Membership can always be terminated with one months' notice.
