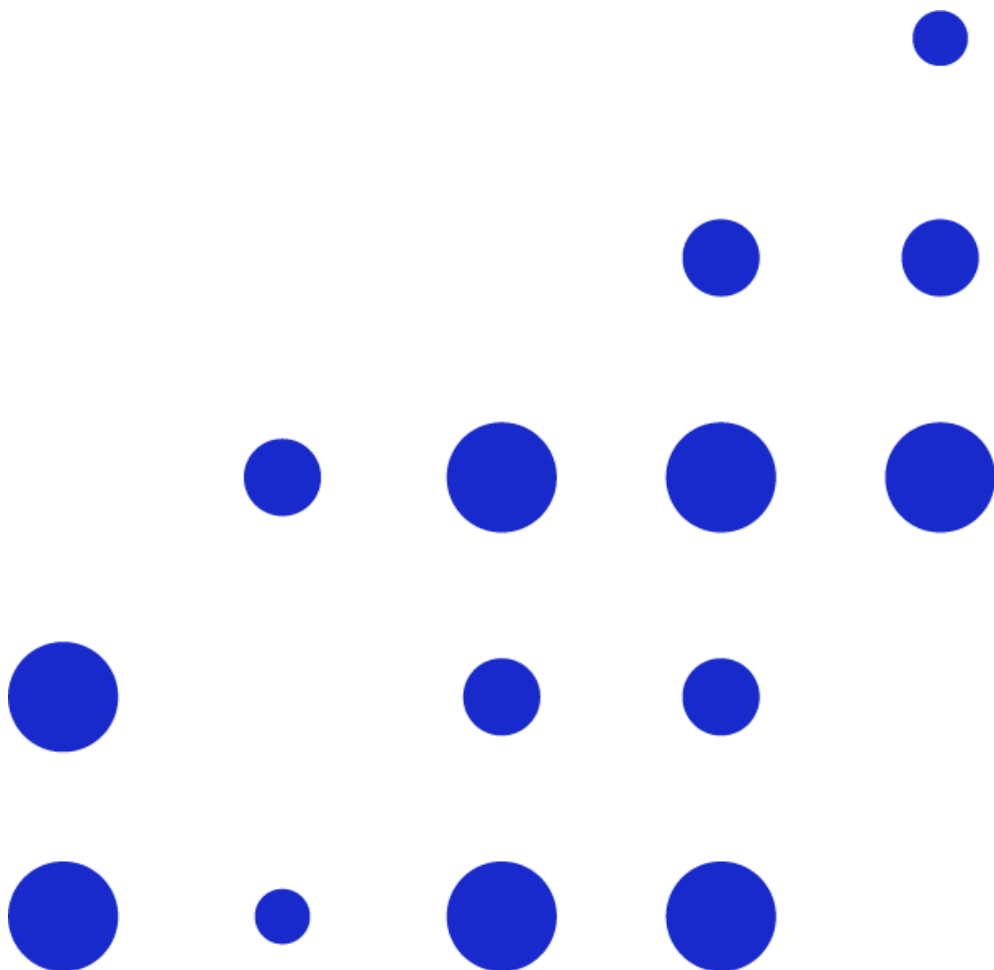


Entrepreneur- membership



Free entrepreneur-membership at The Danish Chamber of Commerce

An entrepreneur-membership at The Danish Chamber of Commerce will give your company a strong, competent, and reliable sounding-board.

The entrepreneur-membership gives new companies free access to a range of The Danish Chamber of Commerce's services for a year.

As a free member of The Danish Chamber of Commerce, entrepreneurs can get access to a valuable network.

To be included in our offer of free entrepreneur-membership the company must live up to the following requirements:

- The company must be less than five years old.
- The company must have a unique CVR-number and must not be a part of a group.
- The company's founders must be a part of the day-to-day running
- The company must not be covered by – or joined an agreement.

- Access to networking and sparring.
- Invitations to events.
- Access to free courses for the companies' employees.
- Access to The Danish Chamber of Commerce's standard contracts.
- Political advocacy
- Membership information and analyses

What happens when your company becomes a member?

When we have received your registration, which we can send to you or you can fill out by following this link www.danskerhverv.dk/lvaerksaetter we will register your company with CVR-number and contact information.

In addition, we will add the employees you ask to be registered and have your company placed in the relevant market and in the industry association, where you have asked for membership.

When all data from your company is registered, you will receive a welcome letter and after that you can feel free to contact us whenever you want.

It would be a good idea to regularly keep yourselves updated in our event-calendar on our homepage, where you can find an overview of what is happening at The Danish Chamber of Commerce regarding entrepreneurs.

It is also possible to register on our homepage, so you can receive news in your mailbox on topics of your interest.

The membership can be used by all employees in the company. So, the more employees that are setup as subscribers on our services, the bigger the membership value is for you.

What happens when the entrepreneur-membership expires?

The entrepreneur-membership is free the first year after your enrollment. During the third quarter your company will be contacted by email about your decision on which kind of membership you would prefer. If The Danish Chamber of Commerce does not receive other information, your company will move to become a full-service member under applicable terms.

Terms for the free entrepreneur-membership

The entrepreneur-membership can at any time be unsubscribed with one months' notice during the first year.

The offer of a free entrepreneur-membership for a year covers new members and not already existing members.
